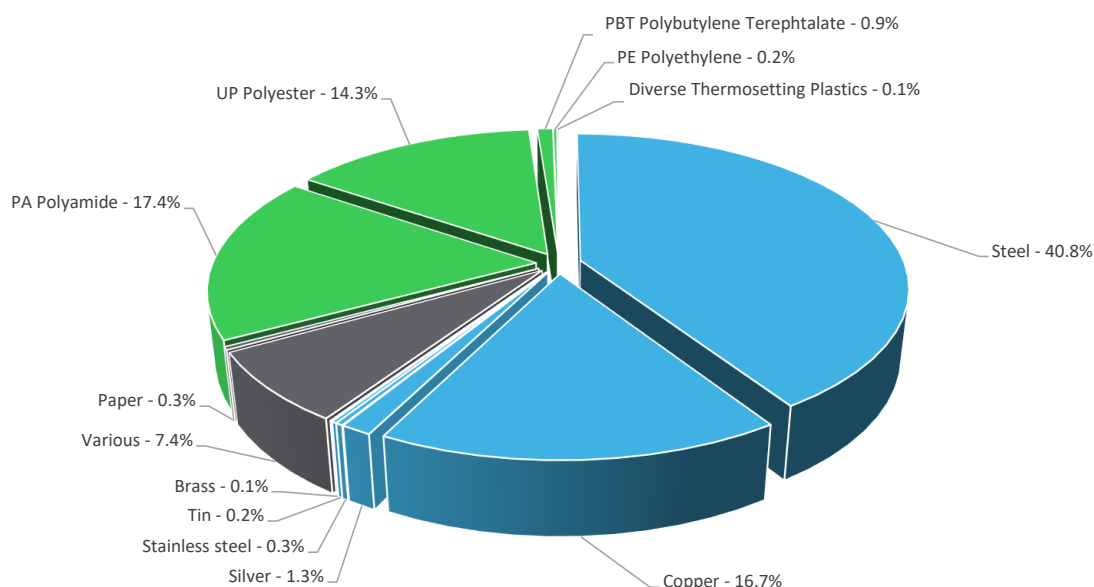
General information
